



ATFA PRODUCT ENDORSEMENT

Application and Agreement

For Equipment, abrasives and fillers.

Products must be from companies that are members of the ATFA

Products may be manufactured locally or overseas

Criteria to be met

- Product information available online.
- A full description of the product including the features of the product, what the product is to be used for and the range that is available.
- For equipment full instructions on how to use the product including safe use.
- For abrasives and fillers full information on using the product including MSDS. This may include aspects of storage, limitations of use, applicable equipment with which it can be used.
- General information on who stocks the product.
- Contact details by phone and email for technical advice.
- Confirmation that the product is suitable for use with the installation and sanding methods outlined in the ATFA Timber Flooring Manual (Timber Flooring 2009).

Applicant Initials:

Confirmation of criteria must be provided by the manufacturer or supplier (as applicable) to ATFA for verification and assessment. ATFA must be satisfied that:

Instructions and information satisfactorily cover the necessary areas for use of the product or consumable.

New products being introduced to the market have been tested to Australian conditions and are compatible with Australian timber flooring products.

That any limitations are known and openly publicised.

Costs per endorsement

The cost structure is based on an initial application and desk audit to verify the credentials of the product put forward, plus an annual fee, which includes a check to verify that conditions with that product have not altered. Note: An endorsement is for one product only and subsequent products must be applied for separately.

Initial application and annual fee for first year: \$1100.00 per product.

Annual Renewal fee: \$330.00 per product.

Recognition process

Once product endorsement is approved by ATFA, the ATFA Endorsed product logo may be affixed or printed on to the packaging of that product (e.g. can, wrapper, box, container). ATFA will provide temporary license to use its trademark during the approved endorsement period.

Dispute Resolution

In the case of a dispute arising, ATFA will action its Dispute procedures (as per the inspection system) and fees will be attributable to the actioning party. Fees commence at \$900.00.

Termination

The ATFA reserves the right to decline providing its endorsement of any product applied for and also to terminate the endorsement of a product forthwith at the sole discretion of ATFA at any time and any application fee shall, if the product endorsement is declined or terminated, be completely forfeited to the ATFA.

Applicant indemnity
